

STATUS OF COMPLIANCE WITH THE LEADERSHIP AND INTEGRITY ACT NO. 19 OF 2012 ON DEVELOPMENT OF LEADERSHIP AND INTEGRITY CODES BY PUBLIC ENTITIES WITH STATE OFFICERS

The Ethics and Anti-Corruption Commission (EACC) is mandated to enforce and ensure compliance with the provisions of Chapter Six of the Constitution, 2010 and the Leadership and Integrity Act, 2012. Under section 37 of the Act, each public entity with State Officers is obliged to develop a Specific Leadership and Integrity Code for the State Officers serving in that public entity. The Specific Codes so developed are supposed to be submitted to the Commission for approval before publication in the Kenya Gazette by the public entities. After publication in the Kenya Gazette, each State Officer is required to sign and commit to the Code gazetted by their respective public entity.

Below is a list of **Public Entities with State Officers** indicating, those that have submitted their Leadership and Integrity Codes to EACC as at **17th August, 2017** as well as those entities that have not yet complied with the requirement to develop and submit Codes to the Commission.
